Single Cart Lease: This allows an individual to ride a club-owned cart for the year, unlimited use. However, if another rider wants to ride with the Lessee, the rider must pay the appropriate cart rental fee.

Couple Cart Lease: This allows the two individuals who share a membership together, to ride a club owned cart for the year with unlimited use. However, if another player wants to ride with a Lessee, the rider must pay the appropriate cart rental fee.

*Due to the increasing number of people borrowing carts and the pro shop not knowing whether permission was granted or not; there will be a fee for the use of a stored cart. A user permission list will be in the Pro Shop and no one else will be granted use of that cart. The club was facing responsibility for property stored on the premises; this will alleviate both the owner and the clubs issues.

A Trail fee will be charged for golfers who ride on a private cart. **Cart Storage members will not be allowed to have guests ride for free.** The guest must pay the cart fee for their round of golf.
